- 6. If I had known at the time that I purchased the Mueller branded products that they were not made or designed in Austria, I would not have purchased them or would have paid less.
- 7. I am not aware of any conflicts of interest with the class members that I seek to represent. In fact, I brought this class action lawsuit in order to stand up for the rights of other consumers in addition to my own.
- 8. I have considered the interests of the class members just as I have considered my own interests, and in some instances, I prioritized the interests of the class members above my own interests.
